- People who post comments or send messages deemed to be offensive or inappropriate will be blocked and may be reported directly to Facebook.
- Content that contains personal information (whether your own or someone else's), including home address, phone number, or personal e-mail address, in order to protect privacy may be removed.

## **Twitter Policy**

We welcome comments and interactions. However, please note that:

- Any content (comments/DMs) that contains abusive, vulgar, offensive, racist, threatening or harassing content, personal attacks of any kind, or offensive terms that target specific individuals or groups will be removed.
- People who post comments or send DMs deemed to be any of the above will be blocked and may be reported directly to Twitter.
- Content that contains personal information (whether your own or someone else's), including home address, phone number, or personal e-mail address, in order to protect privacy may be removed.
- Likes or retweets from our account do not equal endorsement.

## **Instagram Policy**

- Content that contains personal information (whether your own or someone else's), including home address, phone number, or personal e-mail address, in order to protect privacy may be removed.
